Carbon Reduction Projects

The following environmental management measures and projects have been completed and /or planned to be implemented since the 2024 baseline. The carbon emission reduction achieved by these initiatives would equate to reducing the tCO₂e, and help to achieve 20%ge reduction against the 2024 baseline and the measures will be in effect when performing the contract.

- All the electric lights in our premises have been planned to be converted to LED fittings.
- The heating equipment have been planned to be converted to electric ones.
- Have planned to convert all the vehicles to EVs by 2027 thereby nullifying the use of fossil fuels.

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we would be adopting the above-mentioned carbon reduction initiatives.

We project that carbon emissions will decrease over the next five years to 10 tCO₂e by 2030. This would be a reduction of 19.7%

Declaration and Sign Off
